O R D E R

In the circumstances stated by the District Collector, Visakhapatnam and the Spl. CS & CCLA in the references read above, Government, after careful examination, hereby order for transfer of Government land to an extent of Ac. 204.46 cts in Sy.No.480/2 in Nadupuru(V), Pedagantyada(M), Visakhapatnam District in favour of Medical and Health Department for establishment of Medical Technology Manufacturing Park on free of cost, subject to payment ex-gratia to the encroachers and outcome of W.P.No. 2580 of 2008 and also subject to the following conditions in addition to the conditions under BSO - 24 and GO Ms.No.571, Revenue(Assn.I) Dept., dt.14-09-2012.

- i. The land shall be utilized for the purpose for which it is allotted within three years of the orders of transfer.
- ii. The District Collector shall be authority to cancel and resume the land from the allottee for violation of conditions as well as for non-utilization of land.
- iii. The water bodies if any existing in the land should not be disturbed and should be allowed to continue their natural course.

2. The Special Chief Secretary & Chief Commissioner of Land Administration and the District Collector, Visakhapatnam shall take further necessary action accordingly in the matter.
