2. The Director of Medical Education shall follow the procedure envisaged above. Accordingly, the Government hereby authorize the Director of Medical Education, Andhra Pradesh, Hyderabad to issue necessary sanction orders for drawing and adjusting the amount of Rs.25,00,00,000/- (Rupees Twenty five crores only) to the P.D.A/c of District Collector, Visakhapatnam.

3. On presentation of bills by the Accounts Officer, O/o Director of Medical Education, AP, Hyderabad on its admittance and passing the Pay and Accounts Officer, Hyderabad / Assistant Director, AP State Head Quarters, Treasury wing, O/o.DTA, A.P, Hyderabad shall credit the amount of Rs.25,00,00,000/- (Rupees Twenty five crores only) to the P.D.A/c of District Collector, Visakhapatnam and intimate the fact to the Director of Medical Education, AP, Hyderabad, and the District Collector, Visakhapatnam.

4. The amount deposited in the P.D. Account shall be utilized for the intended purpose, and shall not be deposited in any Bank by any authority.

5. The Director of Medical Education, AP, Hyderabad / the District Collector, Visakhapatnam shall take necessary action in the matter, utilize the funds for the intended purpose duly following the prescribed procedure and furnish the utilization certificate / Statement of Expenditure for the amount sanctioned at Para – 1 above to Government.
