The Member of Service shall submit a report of her visit to the Health, Medical & Family Welfare Department, Andhra Pradesh and mark a copy to the Finance/General Administration Department, Government of Andhra Pradesh within one week soon after completion of the visit, specific with well-defined outputs of the visit that could be adopted for the State of Andhra Pradesh.
