**ORDER :**

In the circumstances reported by the Health, Medical & Family Welfare (H) Department, in the reference 3<sup>rd</sup> read above, Government after careful examination of the matter, hereby order the following amendment to G.O 1<sup>st</sup> read above.

**A M E N D M E N T**

- a) Notification-I in the G.O.1<sup>st</sup> read above, shall be read as follows:-

“In exercise of the powers conferred by clause (a) of sub-section (1) of section 9 of the Indian Stamp Act, 1899 (Act II of 1899), the Governor of Andhra Pradesh hereby remits the Stamp Duty in full chargeable under the said Act in execution of Deed of conveyance by Health, Medical & Family Welfare Department in respect of land of an extent of Ac.66.25 cts in Sy.Nos 471-1A, 471-2A, 472-1, 472-2A, 475-1, 475-2A, 476-1, 476-2A, 477-1, 477-2, 477-3A, 480-1 and 481 in favour of Andhra Pradesh Med Tech Zone Ltd for establishment of Medical Technology manufacturing park at Visakhapatnam”.

- b) The paragraph (r) in amendment under Notification.II in the G.O 1<sup>st</sup> read above shall be read as follows:-

“ (r) No registration fee shall be leviable on the execution of deed of conveyance by Health, Medical & Family Welfare Department in respect of land of an extent of Ac.66.25 cts in Sy.Nos 471-1A, 471-2A, 472-1, 472-2A, 475-1, 475-2A, 476-1, 476-2A, 477-1, 477-2, 477-3A, 480-1 and 481 in favour of Andhra Pradesh Med Tech Zone Ltd for establishment of Medical Technology manufacturing park at Visakhapatnam.
