ORDER:

In the circumstances reported by the Health Medical & Family Welfare (H) Department in the reference third read above, Government after careful examination of the matter, hereby order the following Amendment to the G.O. second read above:-

AMENDMENT

- a) Notification-I, in the G.O.2nd read above, shall be read as follows:-

“In exercise of the powers conferred by clause (a) of sub-section (1) of section 9 of the Indian Stamp Act, 1899 (Act II of 1899), the Governor of Andhra Pradesh hereby remits the Stamp Duty in full chargeable under the said Act in execution of conveyance by Health Medical & Family Welfare (H) Deptt, in favour of A.P. Med Tech Zone Ltd on lease agreements between A.P Med Tech Zone Ltd for establishment of Medical Technology Manufacturing Park at Visakhapatnam and Manufacturers in respect of 204.46 acres of land in Sy. No. 480/2 in Nadupuru(V), Pedagantyada (M) Visakhapatnam District”.

- b) Amendment under notification-II in the G.O. 2nd read above, shall be read as follows:-

“In the said “Table of Fees” after category 5(j), the following shall be added, as 5(k) namely:-

(k) No registration fee shall be leviable on the execution of conveyance by Health Medical & Family Welfare Department in favour of Andhra Pradesh Med Tech Zone Ltd on lease agreements between A.P Med Tech Zone Ltd for establishment of Medical Technology Manufacturing Park at Visakhapatnam & Manufacturers in respect of 204.46 acres of land in Sy. No. 480/2 in Nadupuru (V), Pedagantyada (M) Visakhapatnam District under Section 78 of the Registration act 1908.”
